## What is this product?

**Type:** The shares are a class of shares (the "Shares") in Corporate Bond Opportunities (the "Sub-Fund"), a sub-fund of Euromobiliare International Fund (the "SICAV"), a *société anonyme* set up as an Undertaking for Collective Investments in Transferable Securities (UCITS) under Luxembourg law. Euromobiliare Asset Management SGR SpA (the "Management Company") has been appointed as the management company of the Fund. The Sub-Fund is a compartment of an investment fund, whose performance will depend on the performance of its portfolio.

**Term:** The term of the Sub-Fund is unlimited. The board of directors of the SICAV (the "Board") may decide to terminate the Sub-Fund by liquidation or merger under certain circumstances. The Board also has the power to compulsorily redeem your Shares in certain circumstances. The Management Company as PRIIP Manufacturer cannot terminate the Shares, Sub-Fund or SICAV unilaterally.

**Objectives:** The Sub-Fund aims to maintain and gradually increase the invested capital over the medium term. The Sub-Fund may invest its net assets: a) up to 100% in bond-type securities and/or money markets instruments with a rating equal to or greater than BBB- («investment grade»); b) up to 65% in bond-type securities and money markets instruments with a rating below BBB- («not investment grade»); c) up to 10% in convertible bonds, and/or in contingent convertible bonds (CoCo); d) up to 10% in unrated bonds; e) up to 30% in bond-type securities and money markets instruments issued by issuers having their headquarters or conducting their principal activities in emerging countries or by sovereign issuers of such countries; f) up to 10% in units of UCITS and/or UCI investing in fixed income securities. Any investment in "default" and "distressed" securities, such as ABS and MBS is excluded. For information purposes, the average rating of the portfolio will be BB it may decrease depending on investment opportunities likely to arise as a result of the change in the volatility conditions of the bond markets and which may contribute to achieving the performance objective of the Sub-Fund. The overall duration of the portfolio (including derivatives) tends to be between 2 and 7 years. The Sub-Fund is not qualified as a money market fund, pursuant to Regulation (EU) 2017/1131 concerning money market funds, since it is investing in positions which durations do not comply with this regulation. The Sub-Fund may, additionally, hold ancillary liquid assets, under section 5.A.5) of the Prospectus. For investment and cash management purposes and/or in case of adverse market conditions, the Sub-Fund may hold cash equivalents, such as deposits and money market instruments with a residual maturity of less than 12 months. With regard to investments denominated in currencies other than the Euro, the Company has the option of using foreign exchange risk hedging techniques. For the purpose of fulfilling its investment objectives the Sub-Fund may use derivative products such as Options and Futures on interest rates, CDS, CDX and IRS and securities lending transactions for hedging and investment purposes. Forward and Currency Options will be used for hedging purposes only. The Sub-Fund does not have a sustainable investment as its objective nor intends to promote specific environmental or social characteristics as defined by EU Regulation (EU) 2019/2088 on sustainability-related disclosures in the financial services sector ("SFDR") and therefore qualifies as an article 6 product within the meaning of SFDR.

The Sub-Fund is actively managed and refers to the Benchmark to the extent that it seeks to overperform. The Management Company has full discretion to determine the composition of the portfolio of the Sub-Fund and may take exposure to companies, countries or sectors not included in the Benchmark. There are no restrictions on the extent to which the portfolio and performance of the Sub-Fund may deviate from those of the Benchmark.

The Benchmark is constituted up to 45% by the "ICE BofA BBB Euro Large Cap Corporate"; up to 45% by "ICE BofA BB Euro High Yield"; and up to 10% by "ICE BofA Euro Treasury Bill".

The A shares are accumulating.

You can request the redemption of some or all of your shares on any bank business day in Luxembourg.

**Further information:** This Key Information Document describes a class of shares of a sub-fund of the SICAV. The assets and liabilities of each sub-fund of the SICAV are segregated by law, meaning the performance of another sub-fund of the SICAV has no impact on the performance of your investment in the Sub-Fund. You may exchange your Shares for share(s) of another sub-fund of the SICAV, as outlined in the Prospectus, and subject to a conversion fee of up to 0.5% of the net asset value of the Shares to be converted. You can obtain additional documents, such as the Prospectus, as well as the last available annual or semi-annual financial reports, free of charge, in English, at the registered office of the SICAV or on the website [www.eurosgr.it](http://www.eurosgr.it). The Prospectus and the periodic reports are prepared for the SICAV as a whole.

**Intended Retail Investor:** Shares of the Sub-fund may be subscribed by the general public (both professional and retail investors). The typical investor is therefore identified based on the following characteristics: (i) for "retail" investors holds at least a basic knowledge and/or experience of financial instruments; (ii) is willing to hold the invested amounts for a period of time in line with the Recommended Holding Period, i.e., with a time horizon of 5 years years; (iii) is able to bear losses, as the Sub-fund is not guaranteed and is characterized by a risk level of 2; (iv) is seeking an investment that combines income and capital growth.

## What are the risks and what could I get in return?



**The risk indicator assumes that you keep the product for 5 years.**

The actual risk can vary significantly if you cash in at an early stage and you may get back less. You will/may have to pay significant extra costs to cash in early.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movement in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is the a low risk class.

This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact the capacity of issuer to pay you.

Additional risk relevant for the sub-fund, not included in the risk indicator:

- *Liquidity risk*: markets characterized by low volumes may cause difficulties in the valuation and/or trading of certain assets.
- *Credit risk* : possibility of unexpected losses if an issuer of debt securities in which the sub-fund is invested is unable to meet its payment obligations.

This product does not include any protection from future market performance so you could lose some or all of your investment. If the Sub-Fund is not able to pay you what is owed, you could lose your entire investment.

### Performance scenarios

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted. The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product/a suitable benchmark over the last 10 years. Markets could develop very differently in the future.

The figures shown above include all the costs of the product itself, but may not include all the costs that you pay to your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

The stress scenario shows what you might get back in extreme market circumstances.

Unfavourable scenario: this type of scenario occurred for an investment between October 2017 and October 2022.

Favourable scenario: this type of scenario occurred for an investment between January 2016 and January 2021.

## What happens if Euromobiliare Asset Management SGR SpA is unable to pay you?

The assets and liabilities of the Sub-Fund are segregated from the assets and liabilities of the Management Company, meaning the default of the Management Company as PRIIP Manufacturer should not cause you a financial loss. However, if the Sub-Fund is unable to pay what is owed, you could lose your entire investment. The Depositary, who is responsible for the safe-keeping of the assets of the SICAV, is required by law to segregate the assets of the Fund from its own. The Depositary will also be liable, in accordance with the law, if a financial instrument held in its custody is lost, unless it can prove that the loss was beyond its control, in which case you may face a financial loss. Such losses are not covered by any guarantee or investor compensation scheme.

## What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

### Costs over time

The tables below show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product performs. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- that you would get back the amount that you invested in the first year (0% annual return). For the other holding periods we have assumed that the product performs as shown in the moderate scenario;
- that 10.000 EUR per year is invested.

(\*) This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at recommended holding period your average return per year is projected to be 1.2% before costs and -0.5% after costs.

## Composition of costs

<b>Entry costs</b>	1.00% of the amount invested. This is the most you will be charged. The person selling you the product will inform you of the actual charge.
<b>Exit costs</b>	We do not charge an exit fee for this product.
Ongoing costs taken each year	
<b>Management fees and other administrative or operating costs</b>	1.40% of the value of your investment per year. This is an estimate based on actual costs over the last year.
<b>Transaction costs</b>	0.12% of the value of your investment per year. This is an estimate of the cost incurred when we buy and sell the underlying investments for the product. The actual amount will vary depending on how much we buy and sell.
Incidental costs taken under specific conditions	
<b>Performance fees</b>	The performance fee is equal to 20% per year of the positive difference between the performance of the Sub-Fund and the performance of the Benchmark: 45% ICE BofA BBB Euro Large Cap Corporate, 45% ICE BofA BB Euro High Yield, 10% ICE BofA Euro Treasury Bill. The actual amount will vary depending on how well your investment performs. The aggregate cost estimation above includes the average over the last 5 years.

## How long should I hold it and can I take money out early?

### Recommended holding period: 5 years

The recommended holding period was selected to align with the Management Company's projections as to when the underlying investments are most likely to start generating returns. Redeeming your Shares before the end of the recommended holding period may increase your risk of incurring lower or no returns on your investment. You may request, on any day which is a bank business day in Luxembourg, to redeem all or part of the Shares held. Requests for the redemption of Shares shall be made in writing either directly to the UCI Administrator, in the case of direct investment, or through the Principal Placing Agent or the Placing Agent in the country of marketing which had collected the subscription request. Please refer to the Prospectus for further details regarding redemptions.
