## What is this product?

Type: Sub-fund of Euromobiliare International Fund (the "Sicav").

Term: The term of the sub-fund is unlimited. The Company may decide to terminate the sub-fund by liquidation or merger under certain circumstances.

Objectives: The Sub-Fund is equity Sub-Fund and aims to achieve long-term capital grow by investing in a concentrated portfolio of high conviction assets with a long-term investment horizon, diversifying positions, sectors and market capitalizations targets and emphasizing stock selection. The Sub-Fund invests at least 85% of its net assets value in equity securities issued by United States companies that are listed or traded on regulated markets in the U.S. A maximum of 15% of the sub-fund net assets value may be invested in equity securities of non-US issuers listed or traded on regulated markets in the U.S., directly or indirectly via equity-related securities such as American Depository Receipts (ADRs), American Depository Shares (ADSs), Global Depository Receipts (GDRs) or Global Depository Shares (GDSs). The Sub-Fund may also invest in aggregate up to 15% of its net asset value in warrants, closed-ended REITs, and 144A securities eligible and listed or traded on regulated markets in the U.S. Investment in warrants is limited to a maximum of 5% of the Sub-Fund's net assets. The Sub-Fund will not invest in convertible bonds, contingent convertible bonds ("CoCo"), ABS, MBS CMBS and/or distressed or defaulted securities. The Sub-Fund may invest up to 10% of its net assets in units of UCITS and/or other UCIs. The Sub-Fund may, additionally, hold ancillary liquid assets under section 5.A.5) of the Prospectus. For investment and cash management purposes, the Sub-Fund may hold, cash equivalents, such as deposits and money market instruments with a residual maturity of less than 12 months. With regard to investments denominated in currencies other than Euro, the Sub-Investment Manager has the option of using foreign risk hedging techniques. The Sub-Fund is actively managed and refers to the Benchmark to the extent that it seeks to overperforme. The Sub-Investment Manager has full discretion to determine the composition of the portfolio of the Sub-Fund and may take exposure to companies, countries or sectors not included in the Benchmark. There are no restrictions on the extent to which the portfolio and performance of the Sub-Fund may deviate from those of the Benchmark. The Benchmark is : 100% " MSCI USA Price Return USD Index" in euro (index representing large and mid-cap companies on the U.S. market). The A shares are accumulating. You can request the redemption of some or all of your shares on any bank business day in Luxembourg.

# What are the risks and what could I get in return?

## What happens if Euromobiliare Asset Management SGR SpA is unable to pay you?

Between shareholders, each sub-fund is intended to represent a separate entity with its own rights, capital gains, losses, charges and fees. The assets and liabilities of the sub-fund are segregated from those of other sub-funds as well as from those of the Management Company, and there is no cross-liability among any of them. However, if the sub-fund is unable to pay what is owed, you could lose the entire investment as there is no guarantee or compensation system.

## What are the costs?

#### Costs over time

The tables below show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product performs. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- that you would get back the amount that you invested in the first year (0% annual return). For the other holding periods we have assumed that the product performs as shown in the moderate scenario;
- that 10.000 EUR per year is invested.
